Terms & Conditions

- Container & cargo storage are reckoned on per day basis.
- Cargo storage charges are reckoned from the date of carting or de-stuffing to the date of stuffing or delivery for Export and Import cargo respectively.
- Cargo requiring any special service, dun-age, lashing materials or additional equipment for handling will be charged additionally on case to case basis.
- Movement request for export container should be given ten hours prior to container terminal gate cut off time
- CHA will be required to pay Customs overtime, if any required for work done at CFS beyond normal hours and on holidays.
- Charges for cleaning / dumping of spilled liquid cargo or any cargo due to any reason has to be paid by CHA.
- Service tax and other Government levies shall be charged separately at rates applicable.
- All Cheque / DD to be drawn in favor of "ARVIND V JOSHI & CO-CFS" payable at Gandhidham.
- If payment is made through 3rd party cheque a letter from the party making the payment on behalf of importer / CHA has to be provided
- PD account (pre deposit) system is available for clients for easy transactions.
- Prior to movement of Export container or Delivery of import cargo, all CFS dues should be paid.
- It is presumed that all export consignments being received at CFS are adequately insured against all possible risks during transportation, operations, storage etc. and the company(A V JOSHI & CO) assumes no liabilities in this respect. An undertaking from Shipper has to be provided in advance. In case of export cargo like Cotton bales / fabrics / hazardous / dangerous goods copy of the valid insurance policy has to be provided in advance
- The insurance cover for storage risk on import duty/ assessable amount will be obtained by bonded warehouse and the premium @ 12.50 paisa per 1,000/- rupees per week or part thereof will be collected by us from the Consignee
- Levies/Penalties imposed by Government, Judicial, Quasi-Judicial authorities will be recovered from concerned party. Stamp duty payable as per the Govt. of Gujarat guidelines have to be paid in the nominated bank @Rs. 1.00 per 1000/- value of part there off. The original stamp duty receipt, franked on the approved document has to be provided before delivery of the imported cargo in addition to other documents.
- In case any cargo is rejected for delivery by Customs or any other Regulating authorities like District, Drug Controller, Port Health Officer, Plant Quarantine Authority etc. all the expenses related to delivery/disposal should be paid by Importer /Exporter/CHA.
- Hazardous cargo declaration with all details may please be provided for safe handling, stacking & segregation as per norms. The CFS reserves the right for allowing or rejecting specific hazardous commodities in the premises.
- We take maximum care at the time of de stuffing of import loaded containers. In spite of that if there is any damage to the containers the importer / CHA have to settle the matter of repairing of the container with the Shipping Line directly. The CFS will not take any responsibility or the same.
- Carting of cotton bales and other Hazardous cargo will be permitted up to 17.00 Hrs. only to avoid unwanted risk to the cargo.
- Delivery of heavy cargo will be permitted only up to 17.00 Hrs. to avoid accidents and also damage to the cargo
- Scrap loading would be done through machine only. If loading required though labour then extra charge would be applicable.
- Charges for lift on of empty container from other CFS/empty park within Kandla for stuffing at AV JOSHI CFS have to be paid by CHA/SHIPPER and upon submission of payment receipt A V JOSHI CFS shall arrange transportation to bring empty container .
- (•)Seal cutting for import loaded container would be done on written request from the CHA/Consignee and Valid DO of shipping line.
